Our service fee is \$35 to be your Commercial Registered Agent. Our company (Search Company of North Dakota LLC) is a commercial registered agent at the North Dakota Sec. of State. Fee goes by calendar year and renews automatically on 1/1/ of each year however we invoice when the pre printed annual report comes out to us by the Sec. of State for each entity to forward on to clients for clients to file to keep Certificate of Authority in good standing. (Corp. is usually 3/1/ and LLC's are usually 9/1 of each year. Our office is located across the street from the capitol bldg. and we offer counter service filing assistance too.

Our service fee to file an application from email, fax, US mail, or overnight at the Sec. of State is typically \$20 @ doc and we tell our clients if we walk up to the counter to file, that it takes between 1-5 days for routine service and we can provide RUSH service if needed. If clients US mail applications in themselves, it can take the Sec. of State typically twice as long or 10 to 15 days to process US mail however we need a valid reason for immediate filing as the Sec. of State is very busy and only has limited staff to process applications on a daily basis.
